

FINDAWAY WORLD ONE-YEAR LIMITED WARRANTY

Findaway World's warranty obligations for the Playaway® product are limited to the terms set forth below:

When delivered to you in a new condition in its original container Findaway World LLC ("Findaway World") warrants the Playaway® product against defects in materials and workmanship for a period of one (1) year from the date of original purchase ("Warranty Period").

If a defect arises and a valid claim is received by Findaway World within the Warranty Period, as its option, Findaway World will (1) repair the product at no charge, using new or refurbished replacement parts, (2) exchange the product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product.

If a defect arises and a valid claim is received by Findaway World after the first one hundred and eighty (180) days of the Warranty Period, a shipping and handling charge will apply to any repair or exchange of the product undertaken by Findaway World.

Findaway World warrants replacement products or parts provided under this limited warranty against defects in materials and workmanship from the date of the replacement or repair of ninety (90) days or for the remaining portion of the original product warranty', whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes Findaway World's property. When a refund is given, your product becomes Findaway World's property.

Exclusions and Limitations

This Limited Warranty does not apply to any non-Findaway World hardware product, even if packaged or sold with the Playaway® product, including, without limitation earbuds, lanyard and battery. Non-Findaway World manufacturers or suppliers may provide a separate warranty for their own products packaged with the Playaway® product.

This limited warranty covers all defects encountered in the normal use of the Playaway® product, and does not apply in the following cases:

1. Loss of or damage to the Playaway® product due to abuse, mishandling, improper packaging by you, alteration, accident, electrical current functions, failure to follow operating instructions prescribed in Findaway World's user's manual or services performed by someone other than Findaway World or an authorized Findaway World service provider. Without limiting the foregoing, water damage, sand/corrosion damage, battery leakage, dropping the Playaway® product's body, buttons or display, or damage to accessories set forth above, will be presumed to have resulted from misuse, abuse or failure to operate the Playaway® product as set forth in the operating instructions.
2. Use of parts or supplies (other than those sold by Findaway World) that cause damage to the Playaway® product or cause abnormally frequent service calls or service problems.
3. If the Playaway® product has had its serial number altered or removed.
